

Final Instructions

Your rally number is as per the Final Seeded Entry List which has been published alongside these Final Instructions.

Your start time will be 21:20 + your car number.

Please see the MC0 times which will be displayed on the noticeboard at Signing On.

Noise, Scrutineering and Signing on will all take place at the Pavillion, Pontrhydfendigaid. Location will be signposted and marshalled.

Please note the following additions and amendments to the Supplementary Regulations:

The maximum entry for the event is now 75, plus 5 reserves per class.

Fuel

There is no fuel available in the village but it is available in Tregaron, Lampeter, Ponterwyd and Aberystwyth.

PLEASE NOTE THAT THERE WILL BE NO E5 FUEL AVAILABLE IN TREGARON. The nearest petrol stations selling E5 if required are North Road Garage, Lampeter, and Llanbadarn Service Station on the outskirts of Aberystwyth.

Trailers

Competitors bringing their cars on trailers are advised that there will be a trailer park available **AT YOUR OWN RISK** in the field behind the pavilion. Marshals will be there to provide directions.

Noise & Scrutineering

Pavillion, Pontrhydfendigaid, SY25 6BB and will be signposted/marshalled for noise check and scrutineering, which will start at **16:30 hrs** and close at **20:00hrs (MR 135 / 729.25 667)**. On completion of noise and scrutineering you will be guided to your allocated parking slot.

Signing On

Signing On inside the Pavillion will open at **17:00** hrs and close at **20:30hrs**.

Please make sure your marshal has signed on before proceeding to signing on.

There will be a map check, please bring all your maps to signing on.

You will need to produce your completed process card, valid Motorsport UK competition licence UK RS Interclub or higher grade, club membership card (TDMC membership available on the night if required) and declare that you have appropriate insurance.

All outstanding monies to be paid by **CASH ONLY**.

After signing on, competitors will receive a rally pack containing rally plates, time cards and other relevant information.

Insurance

All competitors are required to obtain their own appropriate insurance for their vehicle. A declaration that you have the appropriate cover will need to be completed and signed on the night confirming the name of your insurer and policy number. Please make sure that you do obtain adequate cover as accidents can happen. The club nor Motorsport UK will not be liable for any damage.

Licences

Competitors are required to hold possession of a valid Motorsport UK RS Interclub or higher grade licence. You may not apply for a licence at Signing On.

NO CASH will be accepted by signing on officials in respect of fines for non-production of licences. Cheque only.

Maps

All competitors will need the latest edition of **Ordnance Survey Maps 135 and 146** (1:50 000 series latest edition).

Marshals

Please be aware that the stipulation **no marshal no start will be strictly enforced. All competitors must sign on a marshal by 20.30pm**. This is regardless of whether all the controls may have been filled. Competitors, who are unable to supply a marshal, irrespective of their location and distance travelled to come to the event, will be turned away at signing on.

This may seem harsh, but there will be NO exceptions. Please do not ask us to relax this rule, as refusal often offends.

Marshals will be expected to wear **reflective clothing**, which should be supplied by either the marshal themselves or by their competitor.

Please remind your marshal not to litter. Please make your marshal aware of their requirement to open their control on time, or risk exclusion of their crew.

Scrutineering

We would like to remind competitors that **only** the competing car and the driver and navigator may present the car at both noise and scrutineering.

Damage

All competitors are reminded that it is their duty to report any damage caused to third party property, no matter how insignificant they feel it might be. This can be detailed on the Damage Declaration form and handed in at MC6.

All competitors are required to visit damage control and hand in their damage declaration at MC6 in order to be classified as a finisher as detailed in NCR Ch.13 App.5 Art.11(13.5.11)

Competitors that have been involved in an accident should act as noted below:-

Section 170 Road Traffic Act 1988

DUTY OF DRIVER TO STOP, REPORT ACCIDENT AND GIVE INFORMATION OR DOCUMENTS

1) This section applies in a case where, owing to the presence of a mechanically propelled vehicle on a road, an accident occurs by which -

(a) personal injury is caused to a person other than the driver of that mechanically propelled vehicle, or
(b) damage is caused -

(i) to a vehicle other than that mechanically propelled vehicle or a trailer drawn by that mechanically propelled vehicle,

or

(ii) to an animal other than an animal in or on that mechanically propelled vehicle or a trailer drawn by that mechanically propelled vehicle, or

(iii) to any other property constructed on, fixed to, growing in or otherwise forming part of the land on which the road in question is situated or land adjacent to such land

(2) The driver of the mechanically propelled vehicle must stop and, if required to do so by any person having reasonable grounds for so requiring, give his name and address and also the name and address of the owner and the identification marks of the vehicle.

(3) If for any reason the driver of the mechanically propelled vehicle does not give his name and address under subsection (2) above, he must report the accident.

(4) A person who fails to comply with subsection (2) or (3) above is guilty of an offence.

(5) If, in a case where this section applies by virtue of subsection (1)(a) above, the driver of a motor vehicle does not at the time of the accident produce such a certificate of insurance or security, or other evidence, as is mentioned in section 165(2) of this Act -

(a) to a constable, or

(b) to some person who, having reasonable grounds for so doing, has required him to produce it, the driver must report the accident and produce such a certificate or other evidence. This subsection does not apply to the driver of an invalid carriage.

(6) To comply with a duty under this section to report an accident or to produce such a certificate of insurance or security, or other evidence, as is mentioned in section 165(2)(a) of certificate of insurance or security, or other evidence, as is mentioned in section 165(2)(a) of this Act, the driver -

(a) must do so at a police station or to a constable, and

(b) must do so as soon as is reasonably practicable and, in any case, within twenty-four hours of the occurrence of the accident.

(7) A person who fails to comply with a duty under section (5) above is guilty of an offence, but he shall not be convicted by reason only of a failure to produce a certificate or other evidence if, within seven days after the occurrence of the accident, the certificate or other evidence is produced at a police station that was specified by him at the time when the accident was reported.

(8) In this section "animal" means horse, cattle, ass, mule, sheep, pig, goat or dog.

Rule 286 – Highway Code

If you are involved in a collision which causes damage or injury to any other person, vehicle, animal or property, you **MUST**
stop

- give your own and the vehicle owner's name and address, and the registration number of the vehicle, to anyone having reasonable grounds for requiring them
- if you do not give your name and address at the time of the collision, report it to the police as soon as reasonably practicable, and in any case within 24 hours
